 - the maximum tuition fee the district may charge under Section 25.038 of this code: or (1)
 - the amount the district has budgeted for each student as maintenance and operating expenses. (2)
- (A person found guilty of falsifying information on an enrollment form may be liable for tuition for a sum in excess of \$5,000.)


