# STUDENT DISCIPLINE: PLACEMENT IN A DISTRICT ALTERNATIVE EDUCATION SETTING

REGULATION FOC (LEGAL)

# **DEFINITION**

- <u>Disciplinary probation</u> a formal status imposed on an individual, typically a student, because of violating rules, policies, or codes of conduct established by the institution or organization. When someone is placed on disciplinary probation, they are essentially being given a warning that further infractions could lead to more severe consequences.
- The Director of Discipline will assign disciplinary probation if a student, who has been
  placed or expelled to the Disciplinary Alternative Education Program/Alternative Learning
  Center (DAEP/ALC), has not enroll into DAEP/ALC or completed the number of days
  assigned by the placement or expulsion.

# IMPOSITION OF DISCIPLINARY PROBATION

- a. Disciplinary probation may be imposed by LCISD and the student's home campus following an investigation and determination of misconduct.
- b. Disciplinary probation shall be imposed for a specified period, during which the individual will be subject to certain conditions and restrictions.
- c. The decision to impose disciplinary probation shall be made in accordance with Lamar Consolidated ISD disciplinary policies and procedures.

# **DURATION AND REVIEW**

- a. The duration of the disciplinary probation shall be determined based on the circumstances of the case and the recommendation of the disciplinary body.
- b. At the conclusion of the probationary period, the individual's conduct and compliance with the conditions of probation shall be reviewed to determine whether further action is warranted.

#### **APPEALS**

- a. Individuals subject to disciplinary probation shall have the right to appeal the decision in accordance with Lamar Consolidated ISD District Policy FOC Legal
- b. Appeals shall be reviewed by an impartial body or committee designated to hear the disciplinary appeal.

# **NONCOMPLIANCE**

- a. Failure to meet the conditions and restrictions set forth by the probationary contract will result in the reinstatement of the DAEP placement.
- b. Noncompliance may result in the placement of the student at the DAEP for up to double the number of days set at the time of the probationary contract.

# DOCUMENTATION/RECORDKEEPING

a. Records of disciplinary probation shall be maintained in accordance with applicable privacy laws and LCISD policies.

Information regarding disciplinary probation may be disclosed as necessary for legitimate institutional purposes, including but not limited to student records.



# **2023-24 DAEP Probation Contract**

The purpose of the probationary contract is to provide the student with an opportunity to rectify student behavior due to not attending their DAEP placement. Under the conditions of this contract each student is expected to maintain standards of performance and conduct as outlined by the LCISD Student Code of Conduct and to comply with policies, procedures, and laws. When a student does not meet the expectations set by the administrator or other appropriate authority, disciplinary action may be taken to address the student's behavior.
